## **Update on Shareholders Identification**

KDD (Slovenian CSD) published new (updated) seev messages schemes (also for Shareholders Identification Disclosure Response - seev.047) on SWIFT MyStandards portal, which are used within the SRD II framework and will be in use from November 2024 upgrade of CRVP (KDD information system to support operations of central securities registry system and securities settlement system).

- Swift FINplus seev.047 message (based on Exchange of RMA between KDDSSI22 and intermediaries for the purpose of exchanging XML messages in procedures related to SRD II)
