OTP Bank Nyrt. (company registration number: 01-10-041585, registered seat at: 1051 Budapest, Nádor utca 16., hereinafter referred to as the „**Bank**”), in accordance with Section (2) of Article 304/F. of Act CCXXXVII of 2013 on Credit Institutions and Financial Enterprises (hereinafter referred to as „**Hpt.**”), hereby informs you, as a client covered by the provisions of the Uniform General Terms and Conditions (for POS, mPOS, vPOS card acceptance contracts and automatic card acceptance terminals (CAT)), that the Bank is under no obligation of confidentiality in its relation with OTP Mobil Szolgáltató Kft. (registered seat at: 1038 Budapest, Váci út 135-139. Building 'B', Floor 5, hereinafter referred to as „**OTP Mobil Kft.**”), a company operating under the Bank's control, with regard to data that constitute bank secrets, including personal data, to the extent necessary for the provisions of their services, **the Bank and OTP Mobil Kft. may mutually become aware of these data in the context of their activities, and, as joint data controllers, may, in accordance with the general terms and conditions, transfer data to each other for the purpose of providing access to specific services and may control the data thus received for the duration of the establishment and existence of the customer relationship**, furthermore, data controllers involved in joint controlling based on reciprocal data transfer have the right to contact each other's customers using the data obtained from the data transfer without a specific agreement to that effect, as provided for in Sections (1) to (3) and (5) of Article 164/B. of Hpt.

The Bank informs you that in the framework of the data transfer between the Bank and OTP Mobil Kft. as set forth above based on the provisions of Article 164/B. of Hpt., the following data will be transferred to OTP Mobil Kft.:


- A. Names, titles, e-mail addresses and telephone numbers of natural person contacts and representatives of Clients.
- B. Legal Entity Client's data as follows:
- Client name
 - Client's registered seat
 - Client's company registration number
 - Client's tax number
 - Client's field of activity
 - Client's physical business address
 - Fee payable by the Client to the Bank
 - The commercial terms of the contract, and the text of the contract between the Client and the Bank

The Bank draws your attention to the fact that you have the right to, at any time, restrict or prohibit the transfer of data between the Bank and OTP Mobil Kft. as set forth above based on the provisions of Article 164/B. of Hpt. in an explicit statement.
